Rebate Checklist

Get your rebate check faster by checking off these easy steps before mailing your application form. Incomplete or inaccurate applications may be delayed.

- Submit project online or by mail to receive pre-approval letter
- Once pre-approval letter is received, finish project
- Application completely filled out
- All receipts and a copy of pre-approval letter attached
- Reviewed Terms and Conditions and signed and dated application
- Made copies of all documents and application for your records
- Sent all documents to correct address listed on application

Terms and Conditions

General Eligibility

- Rebates are awarded to help Black Hills Energy commercial/ industrial customers implement natural gas efficiency measures.
- The commercial/industrial Custom Rebate Program buys down energy-efficient upgrades to a two-year payback, or up to one-half of the incremental cost of the equipment, whichever is less.
- Included are rebates for improvements to or replacement of space heating equipment.
- All projects will be individually reviewed for cost effectiveness by Black Hills Energy.
- Projects must pass Black Hills Energy's cost-effectiveness test.
- **Purchase and installations must be completed between Jan. 1, 2011 and Dec. 31, 2011. Applications for work done must be received by Jan. 31, 2012.**
- Rebates will be based on a portion of the incremental cost between a standard product and a high efficiency unit. The amount of the rebate will also depend on:
 - Peak demand reduction
 - Annual energy use reduction
 - Annual energy cost savings

EXAMPLES OF TECHNOLOGIES WHICH MAY BE ELIGIBLE IN THIS PROGRAM INCLUDE:

- Large (≥ 300 MBTUH) High-Efficiency Natural Gas Boilers
- Process Related Equipment for Industrial or Agricultural Customers
- Measures not covered in the Prescriptive Rebate program

IMPORTANT

To be eligible for a custom rebate, please fill out this form and return to Black Hills Energy. Incomplete applications may be delayed. A customer who proceeds without pre-approval or applies to the Custom Rebate Program after the project has been completed may not be eligible for consideration of a custom rebate.

Please do not use this form for rebates on programmable thermostats, forced air furnaces, or other measures that are covered by the Prescriptive Rebate Program. Prescriptive measures must be submitted on the Commercial Prescriptive Rebate Program application form separately.

All projects must be completed between Jan. 1 2011, and Dec. 31, 2011. All applications must be received by Jan. 31, 2012.

POST INSTALLATION VERIFICATION

A firm and final bid or sales receipt indicating date of installation, dealer/contractor name, equipment manufacturer name and model number must accompany the rebate application. Black Hills Energy reserves the right to verify sales receipts, cancelled checks, and installations.

TAX INFORMATION

Rebates may be subject to federal and/or state income tax reporting. Applicant is responsible for contacting a qualified tax advisor to determine tax liability. Black Hills Energy is not responsible for any tax consequences of the rebate program.
