

# AGRICULTURAL REBATE APPLICATION

The Rebate Assistance Program is for eligible Agricultural customers on the Black Hills Gas Distribution, LLC d/b/a Black Hills Energy (formerly SourceGas Distribution, LLC) system. Only customers who are currently enrolled in the AG Choice Gas Program are eligible to apply.

**Customers are eligible when they do one of the following:**

- Connecting new load to Black Hills Energy’s natural gas distribution system
- Connecting a new meter
- Adding a connection to existing meter
- Overhauling an existing natural gas engine
- Repairing or replacing a natural gas line

Rebate must be submitted within six months of purchase date. Annual usage must be at least 3,000 therms. Program runs by calendar year. Funding is limited and available on a first come, first served basis. A copy of supporting cost must be submitted with the rebate form.
