Eligibility Requirements

To be eligible for the rebate, you must:

- Be a residential Black Hills Energy electric customer with an account in good standing. Must also live in a residence that receives electric service from Black Hills Energy and drive an electric vehicle (battery electric or plug-in hybrid).
- Purchase a qualifying battery electric or plug-in hybrid vehicle between January 1, 2024 and December 31, 2024.
 Rebate application must be received by Black Hills Energy on or before December 31, 2024 to qualify for the rebate.
- Qualifying electric vehicle must be registered with the Colorado Department of Motor Vehicles at the same address as the Black Hills Energy electric service address on the customer's account.
- Meet income-qualified requirements as defined in Income-Qualified Eligibility section in the Terms and Conditions, as determined by Black Hills Energy.
- Vehicle must be purchased from an approved dealership that is participating in Black Hills Energy's point-of-sale rebate program.

Failure to meet any of the foregoing requirements may result in denial of the rebate.

Terms and Conditions

Black Hills Colorado Electric, LLC ("Black Hills Energy") is offering this limited time electric vehicle rebate ("EV Rebate") to qualified Black Hills Energy customers purchasing a qualifying electric vehicle ("EV"), consisting of either a battery electric vehicle ("BEV") or Plug-in Hybrid Electric Vehicle ("PHEV"). The EV Rebate is available to qualified customers for the purchase of a new or used qualifying EV.

By signing and submitting this application for the EV Rebate, the Black Hills Energy customer submitting this form: (1) acknowledges that such individual is the account holder whose premises address appears above; (2) acknowledges and certifies the information in this application is accurate and complete; and (3) agrees to be bound by the terms and conditions herein.

Income-Qualified Eligibility

Income qualified customers must provide proof of participation or enrollment in at least one of the following assistance programs: Colorado's Low-income Energy Assistance Program ("LEAP"); Energy Outreach Colorado's Affordable Residential Energy Program ("CARE"); Colorado's Weatherization Assistance Program ("WAP"); Black Hills Energy income-qualified Demand Side Management ("DSM") program; Black Hills Energy's income-qualified Community Solar Gardens; Black Hills Energy Affordability Program ("BHEAP"); any other Black Hills Energy program for income-qualified customers; Supplemental Nutrition Assistance Program ("SNAP"); Temporary Assistance for Needy Families program ("TANF"); Colorado Energy Office's Community Access to Electric Bicylces Rebate Program, or Colorado Energy Office's Vehicle Exchange Colorado ("VXC") Program, subject to verification.

Qualifying Electric Vehicle

The applicant must purchase a new or used BEV or PHEV meeting the following criteria:

Rebate for new EVs – To qualify for the new EV Rebate, the purchased EV: (1) must not have been previously owned or leased and must not have received an EV Rebate under this program (each EV can only receive one EV Rebate over its lifetime); (2) must not have been modified from the original manufacturer's specifications; (3) must have an MSRP that does not exceed \$50,000; (4) must be purchased from a dealership for use by the EV Rebate applicant and not for resale; (5) must be sold as new from the dealership; (6) must be registered at the same Colorado address as the Black Hills Energy customer's electric service address.

Rebate for used EVs – To qualify for the used EV Rebate, the purchased EV: (1) must not have previously received a new or used EV Rebate under this EV Rebate program (each EV can only receive one EV Rebate over its lifetime); (2) must have a purchase price of no more than \$50,000, excluding tax, title, and license fees; (3) must be purchased from a dealership for use by the EV Rebate applicant and not for resale; (4) must be sold as used from the dealership; (5) must be registered at the same Colorado address as the Black Hills Energy customer's electric service address.

Rebate Availability and Limitations

Black Hills Energy offers a limited number of EV Rebates paid out on a first come, first served basis. Rebates are limited to one (1) person, per year with a total limit of four (4) rebates per household, per year. Availability is subject to total number of program participants. Black Hills Energy reserves the right to cancel or modify this EV Rebate program at any time in its sole discretion. Black Hills Energy makes no representations or warranties regarding whether you will or will not qualify to receive the EV Rebate.

By submitting this application, the applicant acknowledges and understands that if any of the information provided is discovered to be false, applicant agrees to pay back any rebate amounts paid by Black Hills Energy. Any information provided in this application may be used internally by Black Hills Energy for purposes other than processing the application and may be made available to the Colorado Public Utility Commission ("PUC"). All personal information will be handled in accordance with applicable laws, PUC rules and regulations, and Black Hills Energy's privacy policy.

The applicant is responsible for adhering to all laws, rules regulations related to the applicant's purchase and use of the EV, and is responsible for paying all fees related to such purchase and use, including but not limited to any vehicle title and registration fee. The applicant is responsible for all tax liability imposed as a result of the EV Rebate, if any. Black Hills Energy is not responsible for any taxes imposed on the applicant as a result of the EV Rebate, if any.

Rebate Stackability with Other Incentive Programs

This rebate may be used in conjunction with other purchase rebate and/or tax credits and incentives programs as long as the total incentive amount does not exceed the purchase price of the vehicle. The applicant agrees to disclose all other incentives and rebates received both at the point of sale and post-sale. Applicant understands that the total rebate payment may be less than \$2,500 if it causes total incentives received to surpass the vehicle purchase price. If applicant fails to disclose any and all incentives received for the vehicle purchase, they understand this rebate payment may be revoked and they could be required to repay the amount back to Black Hills Energy.

Release and Indemnification

representations, warranties, covenants, or guaranties whatsoever, express or implied, in connection with the electric vehicle and
the income-qualified EV Rebate program itself. Black Hills Energy shall in no way be liable or responsible for any electric vehicle
purchase under the EV Rebate program, or for any act or omission of any other entity or individual related thereto, including, without
limitation, the electric vehicle manufacturer or any electric vehicle dealership or other service provider.
