This compliance filing is made in accordance with Ordering Paragraph 2 of Decision No. C25-0685 in Proceeding No. 25M-0391EG setting the Energy Assistance System Benefit Charge ("EASBC") to \$0.83.

The principal purpose of this filing is to increase the EASBC on all applicable rate summary sheets, in compliance with C.R.S. § 40-8.7-105.5(b) and consistent with the EASBC tariffed in Fifth Revised Sheet No. 50. The EASBC will be billed to all utility customers as shown in Table 1 below:

Table 1: Energy Assistance System Benefit Charge

Effective On and after	Rate Schedules	Monthly Charge
October 1, 2021	All	\$0.50
October 1, 2022	All	\$0.75
October 1, 2023	All	\$0.79
October 1, 2024	All	\$0.81

Note: The Monthly Charge shall adjust annually each October 1, beginning in 2023, based on the annual percentage change in the published Index for July in the previous year and July in the current year. Index shall mean the U.S. Dept. of Labor's Bureau of Labor Statistics Consumer Price Index for Denver-Aurora-Lakewood for All Items and All Urban Consumers, or its successor index.

If permitted to go into effect on October 1, 2025, the tariff proposed herein will result in no change to the annual revenues of BHCG. The tariff will effectively be revenue neutral. All revenues collected by the

Company will be transferred to Energy Outreach Colorado net of prudently incurred costs, approved by the Commission, for Company reimbursement.<sup>1</sup>

The projected impacts of the Company's filing on typical monthly bills for Residential customers is shown in Table 2, and for Small Commercial in Table 3.

It is the Company's interpretation that the instant compliance filing is being made to comply with Decision No. C25-0685 setting the EASBC to \$0.83 rather than the utility requesting to increase the rate, and therefore does not require a rate trend report.
