**FOOTNOTES:**

1. Residential, Business 1, and Business 2 rate classes are subject to the Weather Normalization Adjustment Rider. This adjustment is applicable to billings calculated from meters read between November 1 through April 30. The calculation is based on the deviation of actual weather from 30-year normal weather. Irrigation, grain drying, and natural gas vehicles are exempt from this rider.
2. Sales tax and franchise taxes vary by customer's location.
3. Regular business hours are 8 a.m. to 5 p.m. Monday through Friday, excluding Holidays.
4. A convenience fee is charged per transaction for payments made through one of the Company's three alternative payment channels (online at [www.blackhillsenergy.com](http://www.blackhillsenergy.com), via the Company's IVR phone system, or by phone with the assistance of a Customer Care Representative).
5. Commercial and Industrial Large Air Conditioning customers must meter air conditioning volumes separately (second meter). There is no customer charge or administration fee for the second meter. The customer has already paid a customer charge with the primary meter.
