1. Agrees to nominate and use a minimum of 50,001 Ccf per year or
2. Has multiple business accounts under common ownership whose aggregated annual volumes exceed 200,000 Ccf. The aggregated annual volume shall be equal to the sum of the annual consumption of all aggregated accounts.

**FOOTNOTES:**

1. Residential and Small Business rate classes are subject to the Weather Normalization Adjustment Rider. This adjustment is applicable to billings calculated from meters read between November 1 through April 30. The calculation is based on the deviation of actual weather from 30-year normal weather. Irrigation, grain drying, and natural gas vehicles are exempt from this rider.
2. Sales tax and franchise taxes vary by customer's location.
3. Regular business hours are 8 a.m. to 5 p.m. Monday through Friday, excluding Holidays.
