### Pre-approval Checklist

Get your project pre-approved faster by checking off these easy steps.

- Submit project online or by mail
- Completely fill out application (mandatory)**
- Provide in-depth description of existing conditions and proposed project
- Provide manufacturer's equipment cut sheets
- Provide project energy savings calculations (if available)
- Provide project cost detail (if available)
- Provide estimated baseline equipment cost where available
- Make and retain copies for your records

### Rebate Checklist

- Start your project after receiving your pre-approval letter
- Complete project installation
- Attach itemized invoices for equipment and labor, including date of installation
- Attach copy of pre-approval letter
- Make and retain copies of all documents
- Send all documents to address on back of form  
(sending application to the billing address will delay your rebate)

### Terms and Conditions

#### General Eligibility

1. Rebates are awarded to help commercial/industrial customers implement high-efficiency measures and are available to Black Hills Energy non-residential customers.
2. **All Custom projects require pre-approval before purchase and installation.**
3. Multiple rebate applications for different measures may be submitted. Each individual measure will be evaluated on its own merits.
4. Similar measures that are proposed in different facilities or buildings will be evaluated separately.
5. All projects will be individually reviewed for cost effectiveness and must pass Black Hills Energy cost effectiveness test.
6. Black Hills Energy reserves the right to adjust rebate amount based on final project costs as indicated on customer provided invoices.
7. Custom rebates are based on the cost difference (incremental cost) between standard and high efficiency equipment and systems, and the amount of energy saved. Rebates are calculated individually for each project. Projects must have an incremental payback of 2 years or longer. Customer savings will be based on the estimated reduction in billed energy and demand from current usage levels. Projects must have a societal benefit-to-cost ratio of 1.0 or higher. The incentive per kWh savings will be a sliding scale dependent upon the total project kWh savings. Incentive will be calculated based on the cumulative annual kWh savings for all applications submitted by a customer during a program year.
8. \$25,000 per year maximum rebate (custom and prescriptive measures combined) per facility.
9. Applications must be submitted by August 1, 2017.

## Examples of technologies which may be eligible in this program Include:

- Chillers and Unitary HVAC equipment
- High Efficiency Refrigeration Equipment
- Variable Frequency Drives
- Process Related Equipment for Industrial or Agricultural Customers
- Energy Management and Control Systems
- Measures not covered in the Prescriptive Rebate program

## IMPORTANT

In order to be eligible for a custom rebate, please fill out this form and return to Black Hills Energy. A customer who proceeds without pre-approval or applies to the custom program after the project has been completed may not be eligible for a custom rebate.

Incomplete or incorrect applications may be delayed.

Please do not use this form for rebates on measures that are covered by the Prescriptive Rebate Program. Prescriptive measures must be submitted on the Commercial Prescriptive Rebate application form.

## Post Installation Verification

An Itemized invoice indicating date of installation, dealer/contractor name, equipment manufacturer/model number and quantity must be provided. Black Hills Energy reserves the right to verify sales receipts, cancelled checks, and installations.
