

# 2019 Agricultural Choice Gas Supplier Selection Form

AGRICULTURAL PROGRAM SELECTION PERIOD: FRIDAY, FEB. 1-THURSDAY, FEB. 21, 2019

For your convenience, you have three ways in which you may select your natural gas Supplier: via Internet, Mail or Supplier. To make your Selection, please follow the instructions on the back of this form.

Please choose one Supplier and a Pricing Option. Call the Suppliers for a Confirmation Code. Customers MUST obtain a Confirmation Code from their Supplier to receive the price to which they agree.

The Supplier selected for each service address will remain the Supplier for that service address for a full 12 months, beginning April 1, 2019 through March 31, 2020. If you do not make a Selection, you will automatically roll over to the Supplier and default price option you had last year, provided that Supplier is participating in 2019.

Check with your Supplier for your applicable default price. One Selection per service address permitted. The first Selection received will be the customer's final choice.

Non-Jurisdictional Customers: by participating in the Ag Choice Gas Program (ACGS-SS), you hereby agree to be bound by all applicable rates, terms and conditions.

PLEASE NOTE: the Control Number is specific to each customer's service address and is used to ensure that no other party can submit a selection for you. If provided to a Supplier, the Customer has authorized the Supplier to submit their Selection.

# Making Your Natural Gas Supplier Selection

You can submit your supplier selection by automatic rollover, through the Internet, through your supplier or by mail.

Follow the instructions below to submit your selection on or before Thursday, Feb. 21, 2019:

1. Contact each supplier through their website or by the telephone number listed on the front of this form to receive your price quotes and confirmation codes. Verify how long the confirmation code is valid, as the confirmation code ties to a price and energy pricing option.

**Please note: If you have multiple service addresses, you must submit a separate selection for each one.**

2. If you use the Internet, you must have your account number, control number and confirmation code shown on the front of this form. If you do not have your account number and control number, call 877-245-3506. Suppliers provide the confirmation codes.
3. Choose one supplier and one energy pricing option.
4. DO NOT MAIL THE SELECTION FORM TO YOUR SUPPLIER.
5. Choose a submission method from the options below.
6. Once complete, record your agreed-upon pricing option for your records.

## **AUTOMATIC ROLLOVER**

- If you are satisfied with your current supplier and pricing option, simply do nothing, and you will automatically roll over to your current supplier and pricing option. NOTE: Your final rate will be determined within 15 days after the selection period has ended unless otherwise notified by your supplier. Your final rollover price may be different from prices quoted during the selection period.

## **INTERNET**

- Visit **www.ChoiceGas.com** between Friday, Feb. 1, and midnight CST Thursday, Feb. 21, 2019.
- Click on Agricultural Customers, and then click on "Submit your Selection."
- Follow the instructions on the screen to complete and submit your selection.

## **SUPPLIER SUBMISSION**

- Contact your selected supplier.
- Provide your account number and control number.
- NOTE: The control number is for each customer's selection security, and if provided to a supplier, the customer has authorized the supplier to submit their Choice Gas selection.

## **U.S. MAIL**

- Record your five-digit confirmation code obtained from your supplier. (NOTE: If the confirmation code does not match the supplier and pricing option selected, the confirmation code will be used.)
- Sign and date your form, and mail it in the postage-paid reply envelope provided, postmarked on or before Thursday, Feb. 21, 2019.
- If you did not receive, or misplaced, your reply envelope, return your selection form to:

PLEASE NOTE: The natural gas market can be very volatile. We encourage you to check with your supplier regarding the timeframe a given pricing option will be considered valid.
