

# 2019 New Construction Program

## Colorado: Residential Natural Gas Customers

Build an energy efficient home and receive rebates by following one of two paths offered by Black Hills Energy.

1. Prescriptive Standard: Builders may install measures from a selected set of energy efficiency measures (see page 2).

**-or-**

2. Performance Path: Builders must meet a standard of 10% above local code (see page 2).
3. Qualifying homes under either path may be eligible to receive ENERGY STAR® new home labels. ENERGY STAR requires completion of the following checklists to qualify for an ENERGY STAR new home label: (1) Rater Design Review Checklist; (2) Rater Field Checklist; (3) HVAC Design Report; (4) HVAC Commissioning Checklist; (5) Water Management System Builder Requirements.

## Rebate Checklist

Get your rebate check faster by checking off these easy steps before mailing your application form. Incomplete applications may be delayed.

- Completely fill out application (mandatory)**
- Review Terms and Conditions and sign and date application
- Make and retain copies of all documents and applications
- All inspections completed
- Send all documents to correct address listed on application (sending application to billing address will delay your rebate)

## Terms And Conditions

### General Eligibility

1. May be a single or multifamily home up to 5 years old and must be a natural gas customer located in Colorado.
2. **Homes must be completed between Jan. 1, 2019 and Dec. 31, 2019. Applications for work done in 2019 must be received by Jan. 31, 2020.**
3. Space heating systems must use natural gas, be the primary fuel source and for the Prescriptive Path meet the efficiency requirements established for other Black Hills Energy programs (reference the table on page 2). For Performance Path the builder needs to show savings 10 percent above local code, verified by a HERS rating.
4. A Customer who has a Heat Pump or Geothermal system would not be eligible for a rebate.
5. Applications will be processed on a first-come, first-served basis. The program will end when the budget is depleted. Funds are limited.
6. This program is subject to regulatory rules and orders. Black Hills Energy reserves the right to change or to end any portion of this program without notice.
7. Single family homes are defined as single-family detached or attached homes or duplexes. Multi-family homes are defined as three or more multiple units or row houses.

## Black Hills Energy's Recommended Prescriptive Path

Qualify for a rebate by meeting the requirements listed below. The total incentive depends on the measures selected.

NOTE: A HERS rating is required if envelope measures are being applied for.

## Black Hills Energy's Recommended Performance Path

The Performance Path allows builders full flexibility to determine the natural gas savings measure they would like to install. **The only requirement of the Performance Path is that builders are able to verify that the home has natural gas savings 10% above the local code as verified by a HERS rating.**

The total incentive in the Performance Path is \$900 per qualifying home.
