

2017 New Construction Program

Iowa: Residential Customers

Build an energy-efficient home and receive a rebate to help bring costs down.

Qualifying homes may be eligible to receive an ENERGY STAR new home label. Black Hills Energy also offers a rebate for qualifying clothes washer for new home buyers.

Rebate Checklist

Get your rebate check faster by checking off these easy steps before mailing your application form. Incomplete applications may be delayed.

- Completely fill out application (mandatory)**
- Review Terms and Conditions and sign and date application
- Make and retain copies of all documents and application
- Complete all inspections
- Manual J attached
- Send all documents to correct address listed on application (sending application to billing address will delay your rebate)

Terms And Conditions

General Eligibility

1. New home must be in a Black Hills Energy Iowa service territory and have a current Black Hills Energy account number.
2. **Homes must be completed between Jan. 1, 2017 and Dec. 31, 2017. Applications for work done in 2017 must be received by Jan. 31, 2018 or potential incentives will move to 2018 criteria.**
3. Space and water heating systems must use natural gas, be the primary fuel source and meet the efficiency requirements established for other Black Hills Energy programs (starting at 94% AFUE for furnaces or higher and minimum of 0.67 or higher for water heaters).
4. New Homes that have a Heat Pump or Geothermal system would not be eligible for a rebate.
5. Applications will be processed on a first-come, first-served basis. The program will end when the budget is depleted. Funds are limited.
6. Builders must submit Manual J to ensure proper sizing of heating.
7. This program is subject to regulatory rules and orders, and Black Hills Energy reserves the right to change or to end any portion of this program without notice.
8. Under the Plan, rebates are available for single-family homes defined as detached or attached homes, or duplexes or Multi-Family homes defined as up to three units or row houses.

Residential New Construction Prescriptive Program

Qualify for a rebate by meeting all the requirements listed below. The total incentive depends on the measures selected.
