Retention Assistance for Irrigation Load Incentive

Black Hills Energy is now offering up to a \$2,000 rebate to Irrigation customers in Nebraska for the actual costs they incur to replace customer-owned service lines and irrigation engines connected to an existing meter on Black Hills Energy's natural gas pipeline system in Nebraska. Below are examples of equipment covered by the RAIC Program. Similar equipment with comparable estimated usage and/or throughput also may be eligible for the rebate through the RAIC Program.

Examples of equipment connected to existing meters	Rebate	Qty
70 HP engine for 600 hrs. (est. minimum annual usage of 4,200 therms or higher) and associated customer-owned service line	Up to \$2,000	
50 HP engine for 600 hrs. (est. minimum annual usage of 3,000 therms or higher) and associated customer-owned service line	Up to \$2,000	

Rebate Amount: Customers who file a claim for assistance are eligible for up to a \$2,000 bill credit related to distribution after the expense is verified.
