Eligible customers may select any term in whole years between 5 years and 25 years. After the initial term, contracts shall auto-renew with one (1) year terms unless either party provides a contractually-required notice.

Requested subscription level: Customer elects to subscribe to _____% of the energy consumed at the service locations listed above, which equates to _____ kilowatt-hours (kWh).

Eligible customers may choose up to 100% of the energy usage at each service location using in excess of 50,000 kWhs for the 2018 calendar year. The amount of subscribed energy will be converted to a share of renewable energy generating capacity from the Corriedale wind facility.

Program provisions: Customer verifies that they understand the provisions of the Renewable Ready program, including:

1. This application will be qualified for eligibility under the provisions of the program.
2. A formal subscription contract will be required.
3. Renewable energy under the program will not be available until the date the Corriedale Project is commercially operating.

4. All standard rate components under their current tariff(s), as may be amended in the future, will continue to apply.
5. A subscription under this program is in addition to its existing rate schedule(s) and that subscribed energy under this program will be subject to:
 - a. an additional charge for renewable energy (kWh) generated by the customer's share of production in any given billing cycle during the term of this agreement.
 - b. a renewable energy credit.
6. An early termination fee is applicable under the program when customer discontinues taking service at the subscribed premise(s) or when over a 12-month period the customer's load declines to below 90% of the contracted subscription amount, as provided for in the subscriber contract.
7. If customer ceases to receive service at the premises and begins taking service at another location within Black Hills Energy's northeast Wyoming electric utility service territory, Black Hills Energy will automatically transfer the program subscription to the new service location. The subscription shall not exceed 100% of customer's load at new location. If consumption at a new location during the first 12 months of service at the new meter is lower than 90% of the contracted subscription amount, the contract shall be reduced to a contract subscription amount that matches the 12-month energy usage at the new meter and the customer will pay a pro-rated portion of the early termination fee. The original subscription term will continue to apply to the transferred subscription.
8. Any transfer of a subscription between eligible service points will require payment of a \$250 transfer fee.
9. Renewable energy credits (RECs) equal to the renewable energy (kWh) generated by the customer's share of production shall be transferred to or retired on behalf of the subscribing customer.
10. Onsite generation at a subscribed service location shall not reduce a customer's obligations under this program.
11. **This application will only be processed for qualification after payment of the required \$500 application fee.** Multiple applications with different terms and percentages may be submitted by an eligible customer, but only a single application fee per customer will be required.
12. This application, if submitted outside the open subscription period, will be placed on a waiting list until initial allocations are processed. Applications in this status will be processed in the order in which they are received.
