IN THE MATTER OF ADVICE LETTER NO. 834 FILED BY BLACK HILLS COLORADO ELECTRIC, LLC TO INCREASE THE TRANSMISSION COST ADJUSTMENT (TCA) TO BECOME EFFECTIVE JANUARY 1, 2023.

MOTION FOR APPROVAL OF ALTERNATIVE FORM OF NOTICE

Pursuant to C.R.S. § 40-3-104(1)(c)(I)(D) and Rule 1207(b), Black Hills Colorado Electric, LLC (“Black Hills” or “Company”), by its undersigned attorney, requests that the Commission enter an Order approving an alternative form of notice that will apply to Advice Letter No. 834-Electric. By Advice Letter No. 834-Electric, Black Hills seeks to amend its Transmission Cost Adjustment (“TCA”) calculation inputs, on Tariff Sheet No. 101, in the Rates section of its Colo. P.U.C. No. 11-Electric Tariff. The TCA is applicable to all retail customers. Black Hills also asserts that conferral is not required for this Motion according to Commission Rule 1400(a)(I), and that responses to this Motion are not allowed according to Commission Rule 1207(b) except for Trial Staff of the Commission and the Utility Consumer Advocate, who may file a response within two business days of the filing of the motion. In support of the relief requested, Black Hills states as follows:

1. On November 1, 2022, the Company filed Advice Letter No. 834-Electric to amend its TCA calculation inputs on Tariff Sheet No. 101, in the Rates section of its Colo. P.U.C. No. 11-Electric Tariff. The proposed tariff amendment will increase the TCA rate from \$0.005072 per kWh to \$0.006361 per kWh, beginning on January 1, 2023.

2. This Motion only pertains to a request for alternative form of notice for the Company’s amendments to its Tariff to reflect the TCA revisions. However, the Company on

November 15 and November 30, 2021, will be filing separate Advice Letter filings to amend portions of its Tariff concerning its Purchased Capacity Cost Adjustment (“PCCA”) and Energy Cost Adjustment (“ECA”), respectively. Additionally, on September 30, 2022, the Company filed for approval to amend its Demand Side Management Cost Adjustment (“DSMCA”) to be effective January 1, 2023. Given the Company’s requirement to revise its TCA, PCCA, ECA, and DSMCA, the Company is seeking approval in this Motion to provide alternative notice that reflects the filing of these four adjustments.¹ The Commission previously approved consolidated noticing for the TCA, PCCA, and ECA in Decision No. C20-0844-I in Proceeding No. 20AL-0526E.

3. Specifically, Black Hills seeks Commission authorization to use the following form of alternative notice for its amendments to its TCA:
 - a. Filing with the Commission, and keeping open for inspection, Advice Letter No. 834-Electric, which amends TCA calculation inputs, on Tariff Sheet No. 101, in the Rates section of its Colo. P.U.C. No. 11-Electric Tariff. The Company will also post on its website at the time of filing: (1) a Customer Notice attached herewith as Attachment 1 – Placeholder Customer Notice (“Customer Notice”) and (2) Advice Letter No. 834-Electric and its accompanying tariff sheets, for sixty (60) days. The website posting will include a reference to the applicable proceeding number. The applicable website address for the posting of Advice Letter No. 834-Electric, Attachment 1 – Placeholder Customer Notice, and the accompanying tariff sheets is:
<http://www.blackhillsenergy.com/rates/applications>. The Customer Notice includes amendments and impacts of the PCCA, ECA, TCA, and DSMCA filings that have

been proposed to be effective January 1, 2023, so as to provide customers with complete and comprehensive notice of the changes Black Hills is proposing to their rates. As shown in the Customer Notice, the Customer Notice will explain each adjustment and overall bill impact to customers. Though Black Hills provides for Commission review of the Customer Notice, it will not be posted until after the November 30, 2022, filing of the ECA. Black Hills proposed to post the Customer Notice after this date so that it will provide notice to customers of all the rates changes associated with its PCCA, ECA, TCA, and DSMCA filings.²

- b. Printing a message on each applicable customer's bill providing the website URL for the Customer Notice, Advice Letters, accompanying tariff sheets, and a toll-free phone number for assistance, beginning with the December 2022 bill cycle, which will encompass the TCA, PCCA, and ECA amendments proposed to be effective January 2023. Because the bill messages will begin after the filing of the ECA amendments, Black Hills will be able to provide its customers with an aggregated bill impact associated with the amendments to the TCA, PCCA, ECA, and DSMCA. Given that Black Hills will not know the aggregated bill impact until it submits its ECA filing, Black Hills provides below the bill message that will be updated with bill impact information in Black Hills' ECA filing. The bill messages, by customer class, read as follows:

Residential:

"We filed to amend the TCA, PCCA, ECA, and DSMCA rates effective January 1, 2023. If approved, an average monthly residential bill would increase/decrease approximately \$x.xx, or x.xx%. To learn more,

Small Commercial:

“We filed to amend the TCA, PCCA, ECA, and DSMCA rates effective January 1, 2023. If approved, an average monthly commercial bill would increase/decrease approximately \$X.XX, or X.XX%. To learn more visit blackhillsenergy.com/filings or call (888)-890-5554.”

Other Customers:

“We filed to amend the TCA, PCCA, ECA, and DSMCA rates effective January 1, 2023. Customers can call (719)-546-6410 or (719)-546-5869 for information on how the proposed amendments may affect them. Customers can also visit blackhillsenergy.com/filings for more details.”

- c. Publishing a legal notice of the TCA, PCCA, ECA, and DSMCA Advice Letters following the ECA filing on November 30, 2022 (*i.e.*, Attachment 1), with size dimensions of four columns width and 11 inches height, in three newspapers of general circulation for the service territory: (1) *The Pueblo Chieftain* (two consecutive Tuesdays, December 5th and December 12th); and (2) the *Cañon City Daily Record* (two consecutive Fridays, December 7th and December 14th); and (3) the *Rocky Ford Daily Gazette* (two consecutive Thursdays, December 6th and December 13th). Given the number of rate adjustments proposed to be effective January 2023 and to avoid customer confusion, the Company is requesting to consolidate the three rate adjustments into one Customer Notice. Consolidating the rate adjustments into one Customer Notice will assist customers in understanding the full scope of impacts associated with the amendments to the TCA, PCCA, ECA, and DSMCA.

4. In order to properly inform the customers regarding the rate change, the Company would like to use the forms of noticing described above. The Company believes that through noticing customers via bill messages, legal notice publication, and the required website posting, the Company will be able to reach all customers in the service territory in an affordable and efficient manner. In the event the Commission denies this Motion, and determines that additional notice is required, the Company will provide additional notice consistent with the Commission's order.

5. There is good cause for the alternative form of notice requested by this Motion. A bill message, unlike a bill insert, provides more visibility to the customer because it is presented on the first page of the bill, where the customer looks for the dollar amount due and the payment deadline. The website posting will provide the required information regarding the amended tariff sheets to the general public. The toll-free phone number provided in the bill message will give customers a second option to learn more about the amended tariff if they cannot access the internet for the Company's website. The newspaper publications will provide accessible and timely notice across the Company's entire service territory. The newspaper publications will also provide combined notice of the Company's amendments to its TCA, PCCA, ECA, and DSMCA, granting customers comprehensive notice of multiple adjustments that will take effect on January 1, 2023. These alternative forms of notice are expeditious and economic for the Company's customers.

6. Wherefore, Black Hills respectfully requests that the Commission approve the alternative form of notice set forth in this Motion to amend the TCA calculation inputs, on Tariff Sheet No. 101, in the Rates section of its Colo. P.U.C. No. 11-Electric Tariff.
